In the reference 3rd cited a proceeding of increasing CPI points payable under Minimum Wages Act,1948 was issued by the Director of Labour, Telangana, Hyderabad. As per the proceedings, the Managements have to pay VDA from **01.10.2024 to 31.03.2025** for the increased points of Consumer Price Index to the workers. In this regard, **39 CPI points** were increased. **Accordingly, the CPI points were increased from 1849 to 1888.** As per the wages fixed in G.O.Ms. No.11 of LET&F (Lab-II) Department, Dt. 17.01.2012, the Contract Workers are entitled for Basic Wages and VDA from time to time. The revised wages for the period from **01.10.2024 to 31.03.2025** are shown in the annexure.

I therefore request the Managements to ensure payment of wages along with VDA to all contract workers working in your establishments.
